Northern Plains Resource Council is a grassroots family agriculture group and we organize Montanans to protect our water quality, working landscapes, family farms and ranches, and unique quality of life so that we may pass them on, unimpaired, to future generations. We inspire and empower our members with the information, tools, and skills necessary to give them an effective voice in the decisions that affect their lives.

Clean Energy and Climate Change: We met with general managers and board members of three rural electric co-ops to underscore that many farmers and ranchers want to use renewable energy in their operations and that this transition can benefit the co-ops as well. We met regularly with co-op members to gauge interest on how to move their co-ops forward with clean energy. We helped four of our affiliate groups organize efforts in their local communities to acquire and install solar arrays on buildings that serve the public. We organized support for legislative authorization of commercial PACE (property-assessed clean energy) in Montana, which would allow upfront financing for energy upgrades to commercial and multi-family properties. The bill failed by the slimmest of margins but elevated public understanding of how PACE could help Montana businesses and create jobs. We helped members of the public learn about and comment on a rate increase before Montana's Public Service Commission that would have created a new rate class for residential rooftop solar units in order to make residential solar uneconomical. Our work on this issue included publishing a factsheet and holding a public gathering in the state capital to demonstrate public concern. That public concern led the PSC to deny this rate increase. We helped two of our affiliate groups work with their city councils to create energy

Coal and Coal Transition: We published a detailed study (built on the study we released in 2018), in conjunction with Montana AFL-CIO, to provide the structural and technical details of cleanup options for the large coal-fired power plant at Colstrip, MT. The study demonstrated that thorough groundwater cleanup will create far more jobs than minimal cleanup, and will help Colstrip survive economically when the power plants close. We held public programs in Colstrip, Lame Deer, and Forsyth, MT on the job creation potential of thorough groundwater cleanup. These job creation programs were publicized with a mailing to every household in Rosebud County. We held several meetings with staff and leadership at the Montana Department of Environmental Quality, as well as the Governor's office, to explain the evidence for requiring thorough groundwater cleanup at Colstrip. We generated 1,100 public comments on a coal ash cleanup plan that Talen Energy submitted to the DEQ for Colstrip Unit 3 & 4 ponds. We stopped counterproductive state legislation that sought to prop up the coal industry with tax dollars, legislation that would impair Colstrip's ability to prepare for change. We met face-to-face with numerous residents in the Colstrip area each month, including union members, ranch residents, and other community members. We intervened in a federal lawsuit by California and

Agriculture and Local Foods: We organized three "soil crawl" events that provided hands-on programs for rural and urban people interested in improving soil health. We collaborated with the Western Sustainability Exchange, Montana State University, and the Montana Conservation Corps to place four summer interns across the state to test soil for farmers and ranchers, measure the soil's carbon content, and work with those landowners to determine the best way forward to achieve the landowners' goals. After launching the Yellowstone Valley Food Hub to make locally produced foods available to consumers in south-central Montana, we provided fiscal sponsorship, office space and other assistance as the Food Hub builds its business foundation. We held the 4th Annual Montana Local Food Challenge to raise support for local foods. The Montana Department of Agriculture and AERO partnered with us, and five of our affiliates held Local Food Challenge events in their communities. We started building public support for farm-to-school programs in several eastern Montana communities. We met with community-level education leaders and decision makers, and also held a public farm-to-school meeting. We introduced Country of Origin Labeling in the Montana

The primary purpose of the O&F Task Force is to oversee the administration and finances of Northern Plains. The O&F Task Force reports to the Board of Directors on all of its meetings.

We do not have stockholders or different classes of membership. All members in good standing are eligible to vote for officers and at-large board members annually. All members present at the Annual Meeting can introduce and vote on policy resolutions.

The Staff Director and the O&F Task Force review salary and compensation surveys for the region periodically to ensure salaries stay within reasonable parameters.
